### 1. Introduction

COORDINARE - South Eastern NSW Primary Health Network (SENSW PHN) invites grant responses from general practices wishing to nominate female GPs to participate in the Connect Well program, operating within crisis accommodation services in three (3) locations in South Eastern NSW. These locations are:

- Moruya
- Goulburn
- Nowra

The project will run over two (2) financial years from July 2025 to June 2027.

Connect Well is a comprehensive and integrated model designed to meet the health needs of victimsurvivors of family, domestic and sexual violence (FDSV) who have experienced gaps in health care because of experiencing and fleeing FDSV. The program is centred around the development of a dedicated Primary Healthcare Outreach Team (PHOT) which includes a GP, nurse and a health linker position, who work together as a multidisciplinary team to deliver the program at participating crisis accommodation services. This funding opportunity is for the GP as part of the PHOT.

The PHOT will collaborate to provide medical treatment and care coordination. Where there are barriers to access to health care services, brokerage funding will be available for Connect Well clients (women, infants and children).

Wherever possible, the team will link clients with local GPs, PHN-commissioned mental health, AOD and chronic disease services, as well as LHD services.

To support the program, COORDINARE has also secured a partnership with a dental provider which will enhance access to oral health services for Connect Well clients. Access to oral health care will be provided at no cost to the clients of the program.

## Who can apply?

General practices in the Eurobodalla, Shoalhaven or Goulburn-Mulwaree local government areas are eligible to apply for funding and nominate a female GP for this program. There will be an opportunity for the GPs to engage in funded training prior to commencing work for this service.

To apply, complete all sections of the Response template (Attachment 1) and include all relevant documentation. All responses will be reviewed by a Tender Evaluation Panel.

Grant responses close 5:00pm (AEST) on 16 June 2025. Late responses will not be considered.

### 2. Funding

Funded services will run until 30 June 2027.

Funding includes clinic payments as well as funding to support the establishment of these clinics. Clinics will commence in approximately August 2025. These payments are outlined below.

#### Clinic payments



Successful Respondents' GPs will receive a payment of \$1,200 (ex-GST) per four-hour fortnightly clinic to cover non-billable work associated with delivering the program. This payment is not intended to co-fund or duplicate Medicare billing arrangements. GPs may bill Medicare for the delivery of patient care in accordance with the MBS.

Examples of MBS item numbers that could be used are: 23, 91891, 75870, 2717, 739, 10987, 44, 10990, 124, 2712, 24, 47, 2715, 36, 723, 735, 10997, 715, 2713, 721 and 37.

#### Establishment funding

An **establishment payment of \$3000 (ex-GST)** will be provided for work undertaken to support the establishment of the inreach clinic, including liaison with the service, site visits, planning to commence the clinic, establishment of clinic systems and processes.

### 3. Background

#### Funding background

Funding of \$5.748 million over two years from 2024-25 to 2025-26 was announced as part of the May 2024-25 Federal Budget for the *Supporting Outreach Healthcare in crisis accommodation and services* measure to support women and children fleeing family, domestic and sexual violence. It is part of a broad suite of measures to reduce all forms of FDSV against women and children, to support the implementation of the *National Plan to End Violence against Women and Children 2022-32*. COORDINARE was successful in securing a grant and will pilot the Connect Well program in three local government areas.

Building on an earlier pilot on the Central Coast, the Connect Well pilot will address the unmet health needs of victim-survivors with a strong focus on early intervention for infants and children. To improve health outcomes, women and children impacted by violence need to be met where they are, taking account of their circumstances, providing them with choice and ensuring they are supported. Providing integrated health and community services helps reconnect these women and their children to society and rebuild their lives.

#### FDSV needs in South Eastern NSW

Local government areas within the South Eastern NSW region with domestic violence reported assault crime rates per 100,000 population significantly higher than the NSW state average (441.6) are Goulburn Mulwaree (632.2) and Eurobodalla (628.1). Shoalhaven LGA also has very high prevalence (420.6). These levels have risen substantially for most regions since 2021, in particular for Goulburn Mulwaree, which reported 357.7 in that year. Rates for Eurobodalla have remained consistently high, maintaining the highest rates in the SENSWPHN catchment for the past few years. These have contributed to Eurobodalla, Goulburn, and Shoalhaven being the focus areas for the delivery of this program.

#### **Connect Well Commissioning Phases**

Connect Well will be commissioned and implemented in three phases, as described below. This funding opportunity is phase one.

#### 1. Commissioning of General Practitioners

This phase seeks to engage suitable practices who will nominate a GP to participate in the Connect Well program and be part of the PHOT.

GPs engaged as part of the PHOT will deliver a co-located inreach GP clinic at participating crisis accommodation services for four hours per fortnight. Clinic days and times to be determined in



collaboration with the nominated GP and relevant crisis accommodation service. To extend reach of this service, virtual options for primary health care delivery will also be explored for those individuals who require support but do not live at the crisis accommodation service; this could include victim-survivors who are part of the Commonwealth Safe Places Emergency Accommodation and NSW Staying Home Leaving Violence programs. Due to limitations with the location, there may also be occasions where individuals may need to visit a general practice setting for some treatment.

The GP will work to address the unique needs of individuals including facilitating referrals to specialists, completion of assessments required by other services and care plans as required.

#### 2. Commissioning of in-refuge Health Linkers

This phase will engage a 0.5FTE Health Linker role in each of the three crisis accommodation services. The Health Linker is part of the PHOT and aims to remove barriers to care. It will work alongside the GP and Practice Nurse, serving as a direct support for women and children, guiding them through the healthcare system and facilitating access to appropriate health and support services, including follow up and liaison with other appropriate support services. The position will also ensure that the use of existing programs and services is optimised, ensuring the model retains a strong focus on primary health needs of women, infants and children including access to child and maternal health services and other therapeutic interventions. This role will work to facilitate integration, communication, and coordination between health, accommodation, justice, safety and education services.

#### 3. Commissioning of a Practice Nurse

This phase will secure a suitable provider who will employ practice nurse(s) to be deployed as part of the PHOT. All GP clinic referrals will be via the nurse. The nurse will travel between the three sites over five days per week, with days to be determined in collaboration with the relevant crisis accommodation service.

### Scope and Specifications

#### Program Purpose:

The purpose of this funding is to support the primary care response to victim-survivors of family, domestic and sexual violence.

#### **Program objectives:**

- In three sites, develop and implement an inreach model of support to improve quality of care for victim-survivors
- Increase access to holistic and integrated outreach health care to support victim-survivors including those from population groups at higher risk of FDSV
- Increase integration with health and community services to address barriers to accessing health and support services

#### Successful Respondents will be contracted to:

- Provide a 4-hour GP clinic in collaboration with the nurse and health linker at a crisis accommodation service, once per fortnight for the duration of the program
- Work to identify and support localised referral pathways for victim survivors to support comprehensive health care. e.g. referral pathways to clinics in the LHD or to appropriate private specialists\*



- Work with the crisis accommodation service and local health care providers to ensure the successful implementation of the program
- Participate in monitoring and evaluation activities

\*A flexible brokerage fund will be available to pay for external appointments with specialists such as paediatricians and gynaecologists, and allied health practitioners such as speech pathologists, podiatrists and occupational therapists.

#### Location

All funded activities must occur within the **Goulburn-Mulwaree**, **Eurobodalla and Shoalhaven local government areas**, delivering service within the following crisis services:

- Goulburn-Mulwaree: Anglicare community housing, Goulburn
- Eurobodalla: SEWACS Budjangal, Moruya
- Shoalhaven: SAHSSI Shoalhaven Crisis Accommodation, Nowra

Telehealth appointments may also be conducted with clients crisis services who are staying in other temporary housing und programs such as Safe Places Emergency Accommodation and Staying Home Leaving Violence. The Health Linker will be responsible for coordinating GP appointments in consultation with the GP.

#### Data collection

SENSW PHN will work with Department of Health and Aged Care to ensure the collection of relevant program activity data to support program evaluation. Our bespoke Performance Framework includes a customised data capture portal and reporting dashboard where minimum data will be collected, including:

- Client demographics
- Referral and episode of care details
- Service activity detailing occasions of service
- Client experience
- Service provider satisfaction
- Direct or proxy client outcomes
- Cost per service

## 4. Eligibility

Respondents eligible to receive funding under this initiative must be general practices accredited against the RACGP *Standards for general practices*. Nominated GPs must be female and have obtained Fellowship of RACGP and/or ACRRM.
