To ensure the delivery of psychosocial services that are appropriate to the needs of local consumers and integrate with the existing service network.

Description of Activity *

SENSW PHN will:

- continue to commission Commonwealth Psychosocial Support services for 2025-2027 that are in line with the findings of the needs assessment, consultation, outcomes evaluation report and joint planning with the LHDs,
- ensure that services are appropriately distributed and funded based on the region's needs,
- work with commissioned service providers to ensure they meet all data collection requirements and improve data quality.

The Program is designed to support people with severe, often episodic, mental illness who:

- have needs that can be appropriately met through short-term, low intensity support to live independently in the community, as determined through a capacity and strengths-based assessment tool,
- are not restricted in their ability to fully, and actively, participate in the community because of their residential setting (e.g. prison or a psychiatric facility),
- are not receiving similar psychosocial supports through a state or territory government program or the NDIS, where there is potential for duplication of service offering; and
- are aged 16 years and over, noting exceptions can be made for people aged under 16 years subject to approval by the PHN.
